



NOTICE OF CHANGE IN THE SHARE CAPITAL

Rivoli (Turin), 13 January 2025 - **Altea Green Power (AGP.MI, hereinafter "AGP" or "the Company")**, a company engaged in the development and construction of "green energy" plants, further to the press release published on 16 December 2024, announces, pursuant to Article 85-*bis* of the Issuer Regulation adopted through CONSOB Resolution no. 11971/1999, the new composition of the share capital, fully subscribed and paid up, following the assignment of 922,568 newly-issued ordinary shares of Altea Green Power, as a result of the exercise of 1,845,136 Warrants during the Third and Last Exercise Period of the "Altea Green Power 2022-2024 Warrants", ISIN code IT0005472680 (the "Warrants").

The certificate of change in the share capital was filed with the Turin Company Register on 13 January 2025, along with the updated AGP bylaws reflecting the new share capital amount.
